- 1] As per Section 28 (2) (t) of the Maharashtra Public Universities Act, 2016, representation of Registered Graduates to Senate and the allocation of Ten Seats is as given below :

- 2] The Candidate should follow the instructions as given in the relevant Directions of Hon'ble Vice-Chancellor which are already communicated to all Affiliated Colleges/Recognized Institutions vide letter No.KBCNMU/2/Election/23/2022, dated. 14.11.2022.
- 3] The candidate should follow the instructions as given in Uniform Statute 01 of 2017 published by the Higher and Technical Education Department vide its Notification dated 17<sup>th</sup> May, 2017 and Notification dated 28<sup>th</sup> April, 2017, respectively.
- 4] A copy of **Nomination Form** is attached herewith as **Annexure-I**. The candidate should download the nomination form from Election Portal of KBCNMU website [www.nmu.ac.in] and fill in the nomination form manually and submit a hard copy of the nomination form, duly signed, alongwith enlisted documents within the stipulated time limit.
- 5] The detailed procedure and necessary instructions about filling of the Nomination Form, list of documents etc. and other relevant instructions are included in the nomination form.
- 6] The rules for validity and invalidity of nomination form are attached herewith as **Annexure-II**.
- 7] If a candidate is not satisfied with the decision of Registrar & Returning Officer regarding validity of nomination form, he/she can prefer an appeal to the Hon'ble Vice-Chancellor up to 05.00 p.m. on Monday, 16<sup>th</sup> January, 2023, after declaration of valid and invalid list/s.
- 8] The candidate will have to pay Rs.500/- (Rupees Five Hundred Only) as non-refundable nomination fees alongwith nomination form within stipulated time limit. The fees should be paid by Demand Draft of any nationalized bank drawn in favour of Finance & Accounts Officer, K.B.C.N.M.U., Jalgaon or in cash at the cash counter of the University.



- 9] The voter shall have to vote at the specified polling centre fixed by the University and not at any other polling centre.
- 10] The Voter has to produce one of the following documents as a proof of photo identity at the Polling Centre, without which, the voter shall not be permitted to enter in to the polling booth;
- (i) Aadhar Card
  - (ii) Election Card
  - (iii) Passport
  - (iv) PAN Card with Photo
  - (v) Driving Licence
  - (vi) Identity Card issued by Employer; if voter is serving in the Government and Semi-government organization.
- 11] The format of Voting Paper is attached herewith as **Annexure-III.**
- 12] The candidate or his/her agent who shall be a voter of the particular constituency, duly authorised by him/her in writing on his/her behalf, shall only be permitted to be present during counting of votes. No person other than the candidate or his/her authorised agent and the person involved in election process shall be allowed within a radius of reasonable distance from the place of counting.
- 13] The badges for the candidates or his/her agent authorised by him/her in writing on his/her behalf, shall be provided on 31.01.2023 during office hours.
- 14] Only one badge will be issued to each candidate.


