OFFICE ORDER

Subject: Re-constitution of "Grievances Redressal Cell".

On 11th January, 2017, The Government of Maharashtra published The Maharashtra Public Universities Act, 2016 which came into force w.e.f 1st March, 2017 by repelling the provisions of The Maharashtra Universities Act, 1994.

As per the provisions of Sec.79(1) of The Maharashtra Public Universities Act, 2016, (herein after called as the *said Act*), Grievance Committee is required to be constituted to deal with all types of grievances relating to services of the employees of this university as well as its affiliated colleges or recognized institutions, which are not within the jurisdiction of the University and College Tribunal.

As also, Prof.Ambalal Babulal Chaudhari, Head, Department of Microbiology, School of Life Sciences, KBC NMU, Jalgaon was appointed as Dean, Faculty of Science and Technology, in view of office order No.KBCNMU/2/advt.1-2019/167/2019, dt.27th July, 2019. As he has resigned from said post of Dean, his post of Dean, Faculty of Science and Technology is vacant.

As per Direction No.01/2021 Ref.No.KBCNMU/21/14/2021, date-09.03.2021, and as per powers vested to the Acting Vice-Chancellor, is pleased to Nominate Acting Deans and Acting Associate Deans under Sec.15(2) of the *said Act*.


