#### **IMPORTANT INSTRUCTIONS TO THE CANDIDATES**

- 1] The Candidate should follow the instructions as given in the relevant Direction/s issued by the University authorities, from time to time.
- 2] The candidate/s should follow the instructions as given in the Uniform Statute 01 of 2017 published by The Higher and Technical Education Department vide its Notification dated 17<sup>th</sup> May, 2017 and Notification dated 28<sup>th</sup> April,2017. The election shall be held in accordance with the system of proportional representation by means of single transferable vote.
- 3] Election shall be conducted as per amendment made by the Government of Maharashtra vide Ordinance No.XXVIII of 2017 dated 26<sup>th</sup> November,2017 and the Government of Maharashtra vide Ordinance No. I of 2018 dated 20<sup>th</sup> January, 2018.
- 4] A copy of **Nomination Form** is attached herewith as <u>Annexure-1</u>. The candidate should download the nomination form from Election Portal of KBCNMU website [www.nmu.ac.in] and fill in the nomination form manually and submit a hard copy of the nomination form, duly signed, alongwith requisite documents within the stipulated time limit.
- 5] The detailed procedure and necessary instructions about filling in of the Nomination Form and other relevant instructions are included in the nomination form.
- 6] If a candidate is not satisfied with the decision of the Registrar & Returning Officer regarding validity of nomination form, he/she can prefer an appeal to the Hon'ble Vice-Chancellor up to 13.30 hrs. on 29<sup>th</sup> March, 2023 after declaration of valid and invalid list/s.
- 7] The candidate will have to pay Rs.500/-(Rs. Five Hundred only) as non-refundable nomination fees alongwith nomination form within stipulated time limit. The fees should be paid in cash to the cash counter of the University.
- 8) The voter shall have to vote at the specified place in the meeting hall fixed by the University only.
- 9] List of members of Boards of Studies will be published, separately, and will also be updated, from time to time.
- 10] The Candidate/Proposer/Seconder should be a member of Board of Studies in concerned subject.
- 11] Eligibility Criteria for Chairperson of Board of Studies is as published in the Higher & Technical Education Department's Notification dated 28<sup>th</sup> April, 2017

- 1] The programme stands final in the light of provisions of the Act, Statutes & Directions issued by the Government of Maharashtra and Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon, from time to time.
