### NOTIFICATION NO.72/2023

The Government of Maharashtra, vide letter dated 30.11.2017, had promulgated an ordinance to amend Maharashtra Public Universities Act, 2016 (Maharashtra Ordinance No. XXVIII of 2017), wherein it was expected to ensure that the persons belonging to all reserved categories get due representation on the Management Council.

The Government of Maharashtra, vide letter dated 20.01.2018, has, again, promulgated an ordinance to amend Maharashtra Public Universities Act, 2016 (Maharashtra Ordinance No. I of 2018) wherein it was expected to ensure that, the persons belonging to all reserved categories get due representation on the Management Council.

As such, the then Vice-Chancellor has issued the Direction No. 01/2018 relating to the reservation specifying, firstly, that it is necessary to allocate the reservation category "Scheduled Castes" to representatives of managements under clause 30(4)(h) and secondly by drawing of lots for each reserved category under clauses (f), (g) and (i) of sub Section 4 of Section 30 of the Act for the initial term of Management Council immediately after the commencement of the Act. The lots were drawn in presence of the then Vice-Chancellor and representatives of Principal Teacher and Registered Graduate on 01.02.2018. Further, as per Notification No.09/2018 dated 02.02.2018, reservation of other/remaining categories was declared.


Accordingly, considering provisions of the above Act, Ordinances, Direction and Notification issued by the then Vice-Chancellor / Registrar as mentioned above, now, the University, hereby, declares the sequential rotation of allocation of reservation for the Principal Teacher, Representative of Management and Registered Graduate on the Management Council as stated below.

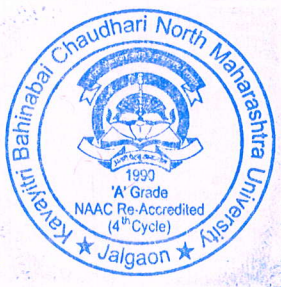

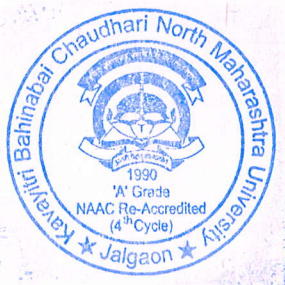
