Directions

Directions regarding constitution of various authorities/ bodies under the provisions of the Maharashtra Public Universities Act, 2016

WHEREAS, under the provision of section 62 of the Maharashtra Public Universities Act, 2016 (hereinafter referred to as "said Act"), the term of every authority constituted under the Act, shall commence from 1st September and shall be of five years from the said date and the process of election, nomination and co-option shall be commenced at least three months before expiry of term of the authority and shall be completed not later than 30th November in that year,

AND,

WHEREAS, Section 67 of the said Act provides that every election to any authority or body of the University shall be held by ballot in accordance with the system of proportional representation by means of the single transferable vote and other details relating to the elections not specified in the said Act shall be as prescribed by the statutes,

AND,

WHEREAS, the Uniform Statutes relating to procedure for conduct of Elections to various authorities and bodies of the universities are prescribed in the Notification of Department of Higher & Technical Education, Government of Maharashtra, dated 17th May, 2017,

AND,

WHEREAS, some points relating to the conduct of elections to the authorities and bodies are not covered under above Uniform Statutes prescribed by the Department of Higher and Technical Education, Government of Maharashtra, these points are required to be regulated by other Statutes,



Now, therefore, I, Prof. Vijay Laxminarayan Maheshwari, Vice Chancellor of the Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon, in exercise of the powers conferred upon me under sub section 8 of Section 12 of the said Act issue directions No. 07/2022 to 14/2022 as follows for regulating the matter for conducting Elections of the Authorities/Bodies of this University :

05	11/2022	Representation of Teachers on Senate
06	12/2022	Representation of University Teachers on Senate
07	13/2022	Representation of Teachers on Academic Council
08	14/2022	Representation of Head of the Departments on Board of Studies

These directions may be called as directions for constitution of various Authorities/ Bodies enacted under provisions of the said Act.

These directions shall come into force with immediate effect.
