CIRCULAR NO: 1 /2022

REGARDING REPRESENTATION OF MANAGEMENT REPRESENTATIVES ON SENATE

(Under Section 28(2)(p) r/w Sec.2 (16) of
The Maharashtra Public Universities Act, 2016.)

1. The Maharashtra Public Universities Act, 2016 (hereinafter referred to as "*said Act*"), is published in the Maharashtra Government Gazette on 11th January, 2017 and came into force w.e.f.1st March, 2017.

In view of Sec.27 of the *said Act*, Government of Maharashtra specify eligibility conditions for being elected, nominated or co-opted as member of authority of the university by publishing Notification dt.28th April, 2017.

2. For the purpose of representation of the Representatives of Management of Affiliated/ Conducted/ Autonomous Colleges and recognized Institutions on the Senate as per Sec.28 (2)(p) r/w Sec.2(16) of the *said Act*, the Registrar shall prepare separate "Collegium of Management Representatives" consisting of representatives of management committees of affiliated or autonomous colleges or institutions and publish the same on the portal of University Authorities Election-2022 on the website www.nmu.ac.in and designated notice board of the University with the names in alphabetical order beginning with Surname, First name, Middle name and College/Institute name, who are eligible to vote for the said election.

However, a Management conducts one or more colleges or institution, only one representative of such management shall be eligible for being included in Collegium of Management Representative.

3. Section 28 (2) (p) of the *said Act* and Notification of Department of Higher and Technical Education, Government of Maharashtra, dated 28th April, 2017, prescribes the eligibility conditions for being elected as a member on Senate.

For the purpose of said election under this section, six representatives of Management are required to elect from among the Collegium of Management Representatives out of whom one seat is reserved for Scheduled Caste or Scheduled Tribe or Denotified Tribes (Vimukta Jatis) or Nomadic Tribes or Other Backward Classes category by rotation and one shall be woman.

Accordingly, to adopt the policy of rotation Direction No. 10/2017, dt.22/7/2017, was issued and for the tenure of 2017-2022, out of these six posts one post was reserved for "Scheduled Caste" and for the subsequent tenure i.e. for the period of 2022-2027 its shall be reserved for "Scheduled Tribes" category.

Said Circular is issued as per directions of Hon'ble Vice-Chancellor.
