Direction regarding representation of Management Representatives on Senate


(Under Section 28 (2) (p) of the Act.)

- (1) For the purpose of representation of the Management Representatives on Senate; the Registrar shall prepare separate Collegium of Management Representatives consisting of representatives of Management Committees of Affiliated or Autonomous Colleges and Institutions and publish an Electoral Roll of the same with the names in alphabetical order beginning with Surname, First name, Middle name and Institute name, who are eligible to vote in the said elections and shall publish on the Election Portal on the University website and designated notice board of the University.

Provided, where a Management conducts more than one College or Institution, only one representative of such Management shall be eligible for being included in the Collegium of Management Representatives.

However, if one and the same person is recommended by more than one Institution, the person so recommended shall be entitled to cast only one vote out of the Institutions of his/ her choice.

- (2) For representation on the Senate, the candidates are required to fulfill the eligibility conditions for being elected as member of Senate as per Section 28 (2) (p) of the said Act and Notification of Department of Higher and Technical Education, Government of Maharashtra, dated 28th April, 2017.
- (3) For this election, one seat will be reserved for Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jaties)/ Nomadic Tribes or Other Backward Classes, **by rotation** and one shall be a woman.
- (4) As the Maharashtra Public Universities Act, 2016 has come into force with effect from 1st March, 2017, and the reservation policy has to be followed **by rotation** i.e. Scheduled Caste, Scheduled Tribes, De-notified Tribes (Vimukta Jaties)/ Nomadic Tribes, Other Backward Classes serially. Accordingly, in this election, it shall be reserved for Scheduled Caste and in subsequent elections, it shall be reserved for Scheduled Tribes, De-notified Tribes (Vimukta Jaties)/ Nomadic Tribes, Other Backward Classes.
- (5) For this election, out of six representatives of the Managements, one seat shall be reserved for Scheduled Tribe and one seat shall be reserved for woman.
