CIRCULAR NO: 2 /2022

REGARDING REPRESENTATION OF UNIVERSITY TEACHERS ON SENATE

(Under Section 28 (2) (s) r/w Sec.2 (19) of
The Maharashtra Public Universities Act, 2016 Act.)

- (1) The Maharashtra Public Universities Act, 2016, (hereinafter referred to as "*said Act*"), is published in the Maharashtra Government Gazette on 11th January, 2017 and came into force w.e.f.1st March, 2017.

In view of Sec.27 of the *said Act*, Government of Maharashtra specify eligibility conditions for being elected, nominated or co-opted as member of authority of the university by publishing Notification dt.28th April, 2017.

- (2) For the purpose of representation of the "University Teachers" as contemplated u/s 2(68) "*said Act*", the Registrar shall prepare separate Collegium of University Teachers consisting of full time teachers of the University Departments, University Institutions and Conducted Colleges appointed by the University and publish the same on the portal of University Authorities Election-2022 on the website www.nmu.ac.in and designated notice board of the University with the names in alphabetical order beginning with Surname, First name, Middle name alongwith names of Institute/ School/ Department/ Centre, who are eligible to vote for the said election.

However, the Teacher appointed on Clock Hour Basis/ Contract Basis/ Temporary Basis/ Teacher appointed after superannuation shall not be included in the Collegium of Teachers.

Names of only those Full Time Teachers who are duly appointed in the University Department, Institute and its Conducted Colleges shall be considered at the time of preparation of Collegium of University Teachers.

- (3) Section 28 (2) (s) of the said Act and Notification of Department of Higher and Technical Education, Government of Maharashtra, dated 28th April, 2017, prescribes eligibility conditions for being elected as a member on Senate.
- (4) For the purpose of election under this section, three teachers are required to elect by the Collegium of University Teachers from among themselves, out of whom one shall be a person belong to the Scheduled Caste or Scheduled Tribe or Denotified Tribes (Vimukta Jatis) or Nomadic Tribes or Other Backward Classes category by rotation and one shall be woman.


Accordingly, to adopt the policy of rotation and considering Direction No.13/2017, dt.22/7/2017, was issued and for the tenure of 2017-2022, out of these three posts one post was reserved for Scheduled Caste and for the subsequent tenure i.e. for the period of 2022-2027 it shall be reserved for "Scheduled Tribes" category.

Said Circular is issued as per directions issued by Hon'ble Vice-Chancellor.
