Direction regarding representation of Teachers on Academic Council (Under Section 32(3) (g) of the Act.)

- (1) For the purpose of representation of the Teachers on the Academic Council; the Registrar shall prepare Collegiums of Teachers by including all Teachers from Collegium of Teacher and Collegium of University Teacher and further publish an Electoral Roll by including the names from both collegiums in alphabetical order beginning with Surname, First name, Middle name and College/ School/ Department/ Institute name, who are eligible to vote in the said elections and shall publish on the Election Portal on the University website and designated notice board of the University.

However, the Teacher appointed on Clock Hour Basis/ Contract Basis/ Temporary Basis/ Teacher appointed after superannuation shall not be included in the Collegiums of Teachers.

- (2) While preparing the Electoral Roll of the teachers, the names of only such teachers of Affiliated, Conducted, Autonomous Colleges shall be included in the Electoral Roll, who are teachers on the date of preparation of Electoral Roll and who have been granted approval by the University and also full time teachers of University Departments, University Institutions and Conducted Colleges, appointed by the University.
- (3) For representation on the Academic Council, the candidates are required to fulfill the eligibility conditions for being elected as a member of Academic Council as per Section 32 (3) (g) of the said Act and Notification of Department of Higher and Technical Education, Government of Maharashtra, dated 28th April, 2017.
- (4) For this election, Two teachers from each faculty shall be elected by the collegiums of Teachers as mentioned above from amongst themselves out of whom, one each shall be a person belonging to Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jaties)/ Nomadic Tribes or Other Backward Class, and reservation per faculty shall be decided by lots.
- (5) After drawing lots of reservation as per clause (4) above, the lots for representation of one woman shall be drawn.
- (6) For the purpose of lots for making decision of reservation in each faculty, Registrar will prepare four chits for categories, viz.

- 1) Scheduled Castes
- 2) Scheduled Tribes
- 3) De-notified Tribes (Vimukta Jaties)/ Nomadic Tribes
- 4) Other Backward Class

And also prepare four chits for Faculties, viz.

- 1) Faculty of Science & Technology
- 2) Faculty of Commerce & Management
- 3) Faculty of Humanities
- 4) Faculty of Inter-disciplinary Studies

Further, the pairs shall be decided on the basis of one chit drawn from each group, i.e. one from category and one from faculty. Hence, the decision about the category to which the seat is to be reserved in the faculty shall be taken.

(7) For the purpose of lot for decision of reservation of seat for woman, Registrar will prepare Eight chits, viz.


- 1) Science & Technology - Open
- 2) Science & Technology - [Reservation category as decided in point No.06]
- 3) Commerce & Managements - Open
- 4) Commerce & Managements - [Reservation category as decided in point No.06]
- 5) Humanities - Open
- 6) Humanities - [Reservation category as decided in point No.06]
- 7) Inter-disciplinary Studies - Open
- 8) Inter-disciplinary Studies - [Reservation category as decided in point No.06]

The seat for woman will be decided by drawing one chit from amongst above.

(8) Lots, to be drawn before the committee appointed by the Vice Chancellor. The committee should consists at least one representative of reserved category and one should be woman. The procedure will be carried out under the chairmanship of Registrar.

(9) The Registrar shall submit decision of lots to the Vice Chancellor for his approval.

(10) The Registrar shall declare the seat allocated by lots for the respective categories after the approval of the Vice Chancellor.
