Sir / Madam ,

With reference to the subject cited above & in accordance with the Regulations referred above at ref. No.1, this is to inform you that, a teacher who fulfills all qualifications under CAS shall submit to the Administration Section the Performance Based Appraisal System proforma as evolved by the university duly supported by all credentials as per the API guidelines set out in these Regulations. Candidate who fulfills all other criteria mentioned in these Regulations, as on 31<sup>st</sup> December, 2008 and till the date of declaration of notification, can be considered for promotion from the date, on or after 31 December, 2008, on which they fulfill these eligibility conditions.

If a teacher is considered for CAS promotion in 2010, one year API scores for 2009-10 will only be considered for assessment. In case of a teacher being considered for CAS promotion in 2011, two years average of API scores for these categories will be considered for assessment.

In the event of any teacher having become eligible for promotion under Career Advancement Scheme (CAS) prior to 31/12/2008, the promotion of such teacher under CAS shall be governed by the old UGC Regulations, 2000 notified vide Notification No.F.3-1/2000 (PS) dated 4<sup>th</sup> April, 2000 as amended from time to time.

The eligible teachers shall submit to the Administration Section through the Director / HoD, the proposed API based Performance Based Appraisal System proforma duly supported by all credentials on or before 19/12/2011

The University has set up variable systems for the API related information as per the tables II (a) II (b) of the regulations. They will have to be documented and collated annually by the Internal Quality Assessment Cell (IQACs) of the university for follow up by the university authorities. In order to facilitate this process, all teachers shall submit through Administration the duly filled-in Performance Based Appraisal System (PBAS) to the IQAC annually.

Therefore, you are requested to bring the contents of this letter to the notice of all concerned teachers in your School/Department. The teachers should go through all concerned appendices of the Regulations while filling up the PBAS proforma.

The API based Performance Based Appraisal System proformas are available on University web site.
