The Appeals Committee and the EC after thorough examination of all the relevant documents and the appeal submitted by you recommended change in the scores of two key aspects i.e key aspect 4.4 Maintenance of Campus Facilities (Revised from 2 to 3) and key aspect 7.1 Environment Consciousness(Revised from 3 to 4) resulting in the increase in the CGPA.


